Subject: \*Additional Bill Added to the FC Markup: H.R. 6082

On Wednesday, July 11, 2012, at 10:00 a.m. in 1324 Longworth House Office Building, the Committee on Natural Resources will hold a markup on the following bills:

- **H.R. 3641**, To establish Pinnacles National Park in the State of California as a unit of the National Park System, and for other purposes. "Pinnacles National Park Act"
- **H.R. 4100**, To strengthen enforcement mechanisms to stop illegal, unreported, and unregulated fishing, to amend the Tuna Conventions Act of 1950 to implement the Antigua Convention, and for other purposes. "*Illegal, Unreported, and Unregulated Fishing Enforcement Act of 2011*"
- **H.R. 4484**, To provide for the conveyance of a small parcel of National Forest System land in the Uinta-Wasatch-Cache National Forest in Utah to Brigham Young University, and for other purposes. "Y Mountain Access Enhancement Act"
- **H.R. 4606**, To authorize the issuance of right-of-way permits for natural gas pipelines in Glacier National Park, and for other purpose.
- **H.R. 5958**, To name the Jamaica Bay Wildlife Refuge Visitor Contact Station of the Jamaica Bay Wildlife Refuge unit of Gateway National Recreation Area in honor of James L. Buckley.
- H.R. 5987, To establish the Manhattan Project National Historical Park in Oak Ridge, Tennessee, Los Alamos, New Mexico, and Hanford, Washington, and for other purposes. "Manhattan Project National Historical Park Act"
- \*H.R. 6082, To officially replace, within the 60-day Congressional review period under the Outer Continental Shelf Lands Act, President Obama's Proposed Final Outer Continental Shelf Oil & Gas Leasing Program (2012–2017) with a congressional plan that will conduct additional oil and natural gas lease sales to promote offshore energy development, job creation, and increased domestic energy production to ensure a more secure energy future in the United States, and for other purposes. "The Congressional Replacement of President Obama's Energy-Restricting and Job-Limiting Offshore Drilling Plan"
