Dear Chairman Rahall,

We call on you to schedule, at the soonest possible time, a Full Committee hearing on President Obama's March 31st announcement of a two year delay in the establishment of a new five-year Outer Continental Shelf (OCS) plan and elimination of numerous lease sales in the current 2007-2012 OCS plan. Our oversight responsibilities demand that the Committee act promptly to hold a hearing to examine the decisions made by the Administration to delay and obstruct offshore energy production and job creation. In these difficult economic times of nearly 10 percent unemployment and with the nation experiencing rising gasoline prices, it's critical that the Committee act to examine the Administration's actions and their impact on new job creation.

As witnesses at the hearing, we ask that you call Interior Secretary Ken Salazar, White House Advisor Carol Browner, and Minerals Management Service Director Elizabeth Birnbaum to testify. In addition, we would ask that a second panel be invited to discuss the impact of the President's actions on the economy, job creation and American-made energy production, and that this panel include the Presidents of the U.S. Chamber of Commerce, National Association of Manufacturers, National Ocean Industry Association, American Petroleum Institute, and Securing America's Energy Future.

It is the Committee's duty and responsibility to conduct oversight on offshore energy production and we hope that you will act quickly to schedule this requested oversight hearing.
