Dear Assistant Secretary Estenoz,

The Committee on Natural Resources (Committee) is concerned about the distribution and stewardship of taxpayer resources appropriated to the Department of the Interior (Department) to address deferred maintenance and repairs, specifically at the National Park Service (NPS). As such, the Committee will be conducting ongoing oversight into the distribution and use of these funds.

During a Subcommittee on Federal Lands (Subcommittee) oversight hearing held on Tuesday, April 18, NPS Director Chuck Sams testified that you personally directed the transfer of \$200 million in funding provided in the Inflation Reduction Act (IRA) to address deferred maintenance to the Presidio Trust, despite the fact that this was not consistent with standard agency practices for selecting priority deferred maintenance projects. As part of its oversight activities, the Committee is now examining this transfer of funds to the Presidio Trust.

As you are aware, the National Park System currently reports approximately \$22.3 billion in deferred maintenance and repairs.² In addition to other discretionary and mandatory funding sources, the NPS was provided with approximately \$1.53 billion this fiscal year, including \$1.33 billion through the Great American Outdoors Act (GAOA) and \$200 million in the IRA, to

address priority deferred maintenance projects across the nation.³ Concerningly, nearly 24 percent of that funding went to one Congressional district, represented by former Speaker of the House Nancy Pelosi, including the entire \$200 million provided for deferred maintenance in the IRA.⁴ Prior to this transfer, the Committee raised concerns and conducted oversight inquiries into the disproportionate amount of funding allocated to former Speaker Pelosi's district compared to the rest of the National Park System.⁵

Director Sams' testimony before the Subcommittee raised numerous questions about whether the hundreds of millions of dollars in taxpayer funding transferred to the Presidio in San Francisco will be appropriately utilized for deferred maintenance and repairs. The Presidio of San Francisco is a 1,500-acre former military installation now used as a public recreation area within the Golden Gate National Recreation Area with pristine golf courses, high-end hotels, and luxury private homes and apartments. During the hearing, Director Sams testified that the Department transferred funding to the Presidio without stipulations or restrictions on whether the Presidio's golf courses or luxury hotels would be eligible federal funding for deferred maintenance or improvements. Additionally, according to a press release posted on the official government webpage of the Presidio Trust, Chief Executive Jean Fraser said this funding will "lay the foundation for the Presidio to be a 'zero climate impact' park." Director Sams testified that this is not a recognized category of deferred maintenance used by the NPS when selecting priority deferred maintenance projects under laws such as GAOA.

Further, despite the fact that both GAOA and the IRA statutorily direct funding to be spent on "priority deferred maintenance projects" within the boundaries of the National Park System, both the Department and NPS failed to adhere to their established criteria and methodology used to select projects eligible for funding. As described in Director Sams' written testimony. NPS typically prioritizes funding to ensure it "is distributed to meet the most critical needs across parks." [emphasis added] Director Sams' testimony explains the importance of this established criteria by stating:

"The criteria the NPS uses when selecting [Legacy Restoration Fund] projects, which it implemented in FY 2021, are similar to the criteria used by other bureaus in the Department and include addressing a significant amount of deferred maintenance, maximizing return on investment, and safeguarding those we serve—our workforce, volunteers, visitors, and partners. Projects that meet the criteria must ensure funds are used to rehabilitate assets to support conservation and recreational opportunities for years to come."11

This "project selection process is built from the ground up" and must be evaluated and approved by regional directors, the NPS Bureau Investment Review Board, a committee of senior managers from the National Leadership Council, and agency and Departmental leadership. 12 According to Director Sams, the \$200 million transfer to the Presidio underwent none of these reviews and was not even a decision made by the NPS.¹³ Failing to adhere to the standard practice of selecting priority deferred maintenance raises serious concerns about why Congresswoman Pelosi's district is receiving special treatment from the Department and the level of oversight conducted prior to this transfer to ensure taxpayer funding continues to be distributed in a transparent and appropriate manner.

Finally, the testimony provided to the Subcommittee yesterday left unanswered questions about the decision making used and transparency of the transfer of \$200 million in taxpayer funding to the Presidio. In September of 2021, the Committee held a markup of budget reconciliation instructions (legislation that would eventually become known as the "Inflation Reduction Act" or "IRA") that explicitly provided \$200 million "to the Presidio Trust ... for carrying out projects identified by the Presidio Trust." ¹⁴ In the final version of the IRA, however,

this language was modified to remove all references to the Presidio and generally address deferred maintenance within the boundaries of the National Park System.¹⁵ Despite the fact the final language in the IRA does not explicitly state this funding shall be used for the Presidio, the Presidio Trust's press release announcing the funding repeatedly credits former Speaker Nancy Pelosi for "securing" this money, including in direct quotes from Presidio Trust Chief Executive Officer Jean Fraser.¹⁶

Director Sams testified multiple times throughout the oversight hearing that he understood it was "Congressional intent" that the funding be transferred to the Presidio Trust and that "direction came through the Department." This raises serious questions about the Department's determination of "Congressional intent", given the fact that Congress *specifically* chose to replace language previously earmarking this funding for the Presidio Trust to instead direct the funds to general deferred maintenance needs in the National Park System as a whole. Further, it raises questions about whether the administration engaged in conversations to modify the final language in the IRA to disguise from the American public that the funding labeled as "deferred maintenance" would ultimately be used for the Presidio. When asked who in the Department directed the National Park Service to transfer \$200 million to the Presidio Trust, in accordance with this supposed "Congressional intent", Director Sams responded that he received this direction from the "Assistant Secretary." 18

As the Assistant Secretary directly overseeing the NPS, the Committee is requesting the following records, documents, or communications, to assist with the Committee's oversight activities, no later than May 5, 2023:

- 1. All documents and communications between or among any employee at the Department of the Interior, including yourself, the White House, the National Park Service and the Presidio Trust referring or relating to the transfer of \$200 million in Inflation Reduction Act funds to the Presidio Trust.
- 2. All documents and communications between or among any employee at the Department of the Interior, including yourself, the White House, the National Park Service, the Presidio Trust and any other public or private office or individual referring or relating to the following topics:
 - a. Funding for the Presidio Trust in the Inflation Reduction Act or similar budget reconciliation legislation.

- b. Funding for deferred maintenance in the Inflation Reduction Act or similar budget reconciliation legislation.
- c. The "Congressional intent" of the deferred maintenance funding provided in the Inflation Reduction Act.
- 3. All documents and communications between or among any employee at the Department of the Interior, including yourself, the White House, the National Park Service, and the Presidio Trust referring or relating to the transfer of \$200 million from the Inflation Reduction Act to the Presidio Trust including, but not limited to, information regarding:
 - a. The date in which the funding from the Inflation Reduction Act was transferred to the Presidio Trust.
 - b. Any restrictions or stipulations on the funding transferred to the Presidio Trust.
 - c. Any reporting requirements associated with the funding to determine whether the funding is being spent on priority deferred maintenance projects.
- 4. Documents sufficient to show the criteria and process used to select priority deferred maintenance projects funded under the Great American Outdoors Act and the Inflation Reduction Act.
