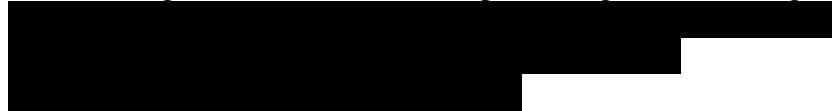

Neither myself nor my organization (CEPA) have received in the current year and previous two calendar years any federal grants or contracts related to liquefied natural gas and/or energy security. The topic of U.S. geopolitics is an expansive one; and it could relate to any/all of the issues we cover at CEPA. In the interests of disclosure, here are the federal grants and/or contracts we have received during the period.

1) In June 2015, the U.S. Department of Defense, Office of Net Assessment granted CEPA \$167,996.00 for an 18-month project entitled *Gaming Allies: Geostrategic Change and Alliances from Athens to America*.

2) In August 2015, CEPA received funding from the U.S. Institute of Peace in the amount of \$2,289.00 for programming on Russian disinformation.

- 3) In September 2015, CEPA received an award from the U.S. Mission to NATO for \$46,936.00 for an 18-month project entitled *Warsaw Summit 2016: What's Next for NATO*.
- 4) In August 2016, CEPA received funding from the U.S. Naval Systems Command/NAVSUP Fleet Logistics Center San Diego for \$194,918.82 for a 12-month project entitled *Strengthening Strategic Stability in Central and Eastern Europe*.
- 5) In May 2016, the U.S. Embassy in Bratislava awarded CEPA a cooperative grant for \$27,272.06 for a 7-month project for the *U.S.-V4 Counter-Disinformation Initiative*.
- 6) In September 2016, the U.S. Department of Defense, Office of Net Assessment granted CEPA \$226,569.60 for a 12-month project entitled *How Rivals Think*.
- 7) In September 2017, the U.S. Department of State, awarded a grant to CEPA in the amount of \$119,042.00 for a 12-month project for *Title VIII fellowships*.
